Statement of Accomplishments

In 2024, our programs boasted 10,223 live attendees, with 177,028 replays of our webinar recordings. We trained 647 Support Group Leaders to help them create vibrant, lasting community gatherings. We also started the Proactive Brain Health series to share preventative strategies for neurodegenerative disease, and integrated the Young Onset Parkinson's Network into our family of programs, centralizing lifetime YOPD support. To make all this possible, our PMD Alliance Ambassadors increased their time volunteering in their local communities by 119%.

We worked directly with long-term and elder care providers and healthcare providers in movement disorders to increase access to informed care. In 2024, 2,373 professionals care providers were PMD Alliance certified in Parkinson's Care. We also awarded 68 continuing medical education scholarships to early-career physicians and matched 44 physicians through our fellows & residents mentorship program. All of these impacts helped us to achieve 4.3 million connections across our ecosystem in 2024.
